# INTRODUCTION

## Restoring the People of Covenant

This work is not written to exalt any ethnicity or political power, for Israel was never a nation defined by bloodline or modern statehood. From the beginning, the People of Covenant were marked by obedience and faith—not by race, geography, or lineage. The Exodus included a “mixed multitude,” and the covenant law was given equally to the native-born and the foreigner who sojourned among them (Numbers 9:14; 15:26, 29; Exodus 12:19, 48–49; Leviticus 16:29; 17:12; 18:26; 19:34). Israel was, and remains, a people of covenant: gathered by belief, dispersed through disobedience, and redeemed through Messiah—an expectation held by Old and New Testament believers alike.

Our intent is to restore the true identity of the covenant people—those who walked in faith and covenant hope, whether descended from Jacob or grafted in among them—and to expose the errors of those who have HIJACKED that heritage for ethnic or political gain. Such claims echo the very impostors condemned by the prophets and by Messiah Himself. This restoration is not racial; it is covenantal, prophetic, and spiritual.

## A History of Corruption

Throughout history, empires and movements—not merely individuals—have labored in the shadows to corrupt truth. What confronts us is not a series of isolated errors, but an ancient and coordinated ideology. From the sixteenth century into our own time, this worldview asserts that certain humans represent a higher, “more evolved” order of being. This belief is not merely political; it is spiritual—and it defines the true battle few are willing to face.

Scripture warns us of this mindset even before the Flood. The fallen angels took human women and produced the Nephilim—giants whose thoughts were “only evil continually.” The contrast with Noah is deliberate. These beings corrupted creation, stirred wars, and defiled mankind, beasts, and even plants. Messiah warned in Matthew 24 that the “days of Noah” would return in the Last Days. Revelation speaks of two Beasts—global powers who will again manipulate creation to enthrone evil. These are not allegories but literal world systems rising before our eyes.

Many point quickly to Islam’s Mahdi, and indeed that figure plays a role. Yet few recognize that extreme factions within Judaism teach a nearly identical expectation: a militant messiah of conquest, ushered in through chaos and global upheaval. This book does not attack Jewish ethnicity, nor does it condemn all practitioners

of Judaism. Instead, it exposes what Henry Ford once termed the “International Jew”—not the common man, but a sect, a cultic ideology, that has HIJACKED Israel’s identity, precisely as defined in Revelation 2:9.

Figures such as Shabbethai Tzvi (c. 1666) openly preached “redemption through sin,” leading millions into apostasy. Their doctrine was not new—it was the same ancient satanic ambition to rule the world. Such factions became financiers, weapons suppliers, advisers of kings, and architects of war. Their fingerprints mark history, yet their roots reach far deeper.

This is not speculation. The historical and biblical record together reveal a two-thousand-year conspiracy: to redact Scripture, rewrite history, corrupt language, and exalt impostors in the very place of God’s people. It is, quite literally, the ideology of the Nephilim—declaring all others inferior, fit only to be ruled or destroyed. And if these impostors also masqueraded as God’s covenant heirs, that would be the greatest identity theft in human history.

### **Linguistics Gone Wild**

This book will examine that claim. We will test whether modern “Israelites” align with biblical Israelites—not through assumptions, but through language, history, Scripture, and the witness of geography itself.

Even our English Bibles have been altered. The English term “Jew” does not appear in the original Hebrew or Greek manuscripts. Such substitutions profoundly affect how readers perceive prophecy. When tested honestly, the impostors are exposed—claiming to be Israel, yet proven otherwise by the biblical and historical record.

### **The Language of Creation**

According to Jubilees 12:25–27, Abraham rediscovered the “language of creation”—the holy tongue spoken by Adam, Enoch, and Noah before Babel. Scripture calls this language Ibrit, the speech of Eber, from whom the word “Hebrew” (Ibri) derives (Genesis 14:13; Josephus).

This was the original language of covenant—used for prophecy, prayer, law, and revelation long before the tribe of Judah existed. When the northern kingdom fell, Judah remained the final kingdom preserving that sacred tongue. Foreign nations therefore labeled the language Yahudit—“the speech of the Judeans”—not because Judah invented it, but because Judah was the last to protect it. Yahudit thus became a geopolitical label for the same ancient language of Creation.

## **The Meaning of Yahudim and Yahudit**

The Hebrew terms Yahudim (people) and Yahudit (language) have been misunderstood through later translations that rendered them “Jews” and “Jewish,” introducing political and ethnic connotations foreign to Scripture.

*In Hebrew:*

Yahudim designates the people of Yahu—the covenant people belonging to Him.

Linguistically, scholars derive Yahudim from Yahudah (Judah), meaning “Yah be praised” (Genesis 29:35).

But the deeper covenant identity traces back to Yahu, the divine Name, not to a tribal designation.

Thus, while linguists force Yahudim into the meaning “those of Judah,” the covenant reality remains: their identity derives from the Name of Yahuah Himself. The language (Yahudit) and the people (Yahudim) share one root—Yahu, the Creator and Covenant-Giver.

This is why the Apostles taught that there is neither Jew nor Greek in salvation; all can enter covenant life through Messiah. That was not a New Testament innovation—Gentiles were already part of Abraham’s household and the Exodus community. Even Pharisees who believed on Yahusha entered the covenant.

## **The Covenant Standard: Fruit as Identity**

*Paul affirms this truth:*

- ✓ “He is not a Yahudi who is one outwardly... but one inwardly” (Romans 2:28–29).
- ✓ The olive tree in Romans 11 is covenant, not ethnicity.
- ✓ Messiah defined His own by their fruits (Matthew 7:16–20).

Therefore, the true Yahudim are recognized not by ancestry or geography but by covenant obedience. Whether native-born or grafted in, all who walk in Yahuah’s ways form one family of faith, restored to the covenant of their Creator.

Their tongue is Yahudit—the language of truth.

Their identity is covenant fruit.

Their purpose is to bring praise to Yahuah, whose Name they bear.

Just as Solomon’s wisdom exposed the impostor mother, so will this Synagogue of Satan be unveiled in our age.

## A History Ignored

The Northern Tribes were taken by Assyria and replaced with foreigners—pagans who attempted to mix their worship with that of Israel (2 Kings 17). Scripture never records their return. All the tribes were taken, leaving only Judah and Benjamin. The Southern Kingdom later returned from Babylon by decree of Persia, yet even then the Samaritans—foreigners, not Israelites—opposed the rebuilding.

By 165 BC, the Hasmoneans—Samaritans of Philistine and Gath origin (Chasmoniiim: Genesis 10:14, Septuagint)—marched from Modi'in (in Samaria; 1 Maccabees 2:15), usurped the priesthood, seized Jerusalem, and established an unbiblical dynasty. They expelled the sons of Zadok, created a counterfeit Sanhedrin, and rewrote Israelite religion. The Dead Sea Scrolls confirm that the legitimate Zadokite priesthood continued covenant worship in exile at Qumran, awaiting Messiah.

Messiah did come—and the impostor priesthood opposed Him, exactly as Daniel, David, and Enoch foresaw. John the Baptist—of priestly lineage—and the Zadokite remnant received Him. After the resurrection, the apostles carried the truth, while the Pharisees twisted Paul's letters, demanded circumcision for salvation, and injected their leaven into the ekklesia. Paul, once a Pharisee, denounced their traditions as bondage. Josephus, their historian, claimed Hasmonean descent and Pharisee affiliation, though seminaries rarely acknowledge his own admissions (The Life of Flavius Josephus 1:2; War 2.8.11–12).

The apostles knew the truth: all twelve tribes were already scattered (James 1:1; 1 Peter 1:1). Yahusha identified the Lost Sheep as those in the Northeast—modern Kurdistan—fulfilling Isaiah 11 and 2 Esdras 13. These were of the Northern Kingdom, called the “House of Israel,” never a title for Judah after the schism. Yahusha forbade the disciples from going through Samaria because Samaritans were foreign settlers, not Israelites.

Most of the tribes never returned to the Levant. Many remained in regions of Syria, Turkey, Iraq, and Iran (Kurdistan). Thus, all twelve tribes were absent from the land long before Rome destroyed the Temple in 70 AD.

Modern rabbinic stories of tribal survival in Judea are fabrications designed to sustain the impostor narrative.

Constantine—an inheritor of this deception through the Flavian line—made Catholicism Rome's state religion and moved the imperial center to Asia Minor: the “seat of Satan” (Revelation 2:13). Later, Pharisaic Judaism migrated through the Russian steppes into Europe. The Khazar conversion to Judaism does not prove

the Lost Tribes' identity; it proves the Lost Tribes were not practicing Judaism, for Rabbinic Judaism descends from the Pharisees themselves (as openly stated in the Jewish Encyclopedia).

Isaiah 11 promises the tribes' return from the four corners of the earth—something the 1948 State of Israel does not fulfill. Ezekiel 38 instead describes a false Israel under siege—aligned with the very powers masquerading as God's people today. Jubilees 9 identifies Magog's inheritance as the islands and coasts of the West—pointing to Western and Central Europe, the colonial empires. The British Empire conquered the land then called Palestine and transferred it to their ideological allies—those fitting the Gog-Magog profile.

It is no surprise what judgment this will draw from Yahuah in time.

*Messiah warned:*

“I know the blasphemy of those who say they are Yahudim and are not, but are the synagogue of Satan.” — Revelation 2:9

“Behold, I will make them of the synagogue of Satan... to come and worship before your feet...” — Revelation 3:9

*He named them: impostors, liars, infiltrators.*

Christianity has largely ignored His words, but prophecy demands we confront them. These counterfeit heirs will one day bow before the true exiled tribes. The identity of Israel is not peripheral—it is central to prophecy, salvation history, and the last days.

## The Synagogue of Satan in Context

“I know thy works, and tribulation, and poverty, (but thou art rich) and I know the blasphemy of them which say they are Jews (Yahudim), and are not, but are the synagogue of Satan.” – Revelation 2:9 (KJV)

“Behold, I will make them of the synagogue of Satan, which say they are Jews, and are not, but do lie; behold, I will make them to come and worship before thy feet, and to know that I have loved thee.” – Revelation 3:9 (KJV)

Messiah Himself introduced the phrase synagogue of Satan. He did not use metaphor, exaggeration, or allegory. He identified a real group of people making a real covenant claim they did not possess.

From the beginning, the question is unavoidable:

If Yahusha defined a counterfeit Israel in the first century, and Revelation shows them still functioning at the end of the age, then who were they – and where are they now?

To answer that, we must begin with a simple but essential foundation:

### Where Did Synagogues Come From?

Search any modern source:

*“Do any religions besides Judaism call their places of worship synagogues?”*

*The answer: only Rabbinic Judaism, the admitted continuation of Pharisaism (Jewish Encyclopedia).*

This creates a problem for modern assumptions, because:

- ✘ Synagogues do not appear in the Old Testament.
- ✘ Not once.
- ✘ Abraham did not worship in synagogues.
- ✘ Moses never built one.
- ✘ Joshua, Samuel, David, Solomon – none mention them.
- ✘ The prophets never used them.
- ✘ Ezra restored the Temple, but never established synagogues.
- ✘ The entire Apocrypha is silent on synagogues.
- ✘ The Dead Sea Scrolls – written by the actual Temple priesthood – also contain zero reference to a synagogue system.

The first time synagogues appear in Scripture is during the Gospels – after the Hasmonean and Pharisaic takeover of Judea (165 BC onward).

Their existence is not evidence of biblical precedent, but Pharisaic innovation.

Later Greek copies of the Septuagint retroactively inserted the word synagogue into Old Testament contexts – but no original scrolls contain it.

Messiah and the apostles taught in synagogues because they existed in their day – not because they were part of Moses' covenant system.

### **Why Messiah's Words Cannot Be Allegorized**

Many attempt to soften Yahusha's rebuke by spiritualizing it:

“It's symbolic.”

“It refers to unbelievers in general.”

“It's just a warning about hypocrisy.”

But Yahusha did not rebuke a vague idea.

He confronted a specific priesthood and leadership system in the real first-century world –

# TEMPLE WORSHIP VS. SYNAGOGUE SYSTEM

## TEMPLE WORSHIP (BIBLICAL)

One central location: The Temple in Jerusalem (Deut. 12:5–14).

Priestly order: Sons of Aaron and the Levites (Num. 18:1–7).

Sacrifices: Daily burnt offerings, festivals, sin offerings (Lev. 1–7; Num. 28–29).

Pilgrimage feasts: Passover, Shavuot, Tabernacles (Deut. 16:16).

Authority: Torah and prophets, overseen by Zadokite priests (Ezek. 44:15).

Focus: Worship of Yahuah through covenant sacrifice and obedience.

## SYNAGOGUE SYSTEM (PHARISAIC, POST-165 BC)

Many local houses: Community gathering halls, not commanded in Torah.

Rabbinic teachers: Pharisees elevated oral traditions over Scripture (Mark 7:6–13).

No sacrifices: Replaced by prayers, readings, and man-made rules yet they reject the Messiah annulling something they could not. Leaven!

Sects and councils: Pharisees, Sadducees, Sanhedrin — all absent from Old Testament law.

Authority: Oral law (later codified in the Mishnah/Talmud).

Focus: Control of the people through added traditions (“leaven”).

### *Key Point:*

The synagogue system, as it developed later, was never instituted by Moses, Ezra, or the prophets. In His rebukes, Messiah identified the fruit of that system’s corruption as spiritually opposed to Yahuah’s intent.

“Ye shall know them by their fruits...” (Matt. 7:16, 20).

The fruits Messiah listed are unmistakable. To ignore them is negligence. To confront them is not hatred, but obedience. Paul asked, “Am I therefore become your enemy, because I tell you the truth?” (Gal. 4:16).

Even when Pharisees were offended (Matt. 15:12), Yahusha replied: “Every plant, which my heavenly Father hath not planted, shall be rooted up. Let them alone: they be blind leaders of the blind.” (Matt. 15:13–14)

### Who Are They Today?

The Jewish Encyclopedia states:

“Pharisaism shaped the character of Judaism... for all the future.”

In plain language:

**Modern Rabbinic Judaism = Pharisaism.**

Yahusha’s rebukes were not against the common people of Judea.

*They were against the leaders who:*

- ✘ seized the priesthood illegally,
- ✘ replaced Torah with tradition,



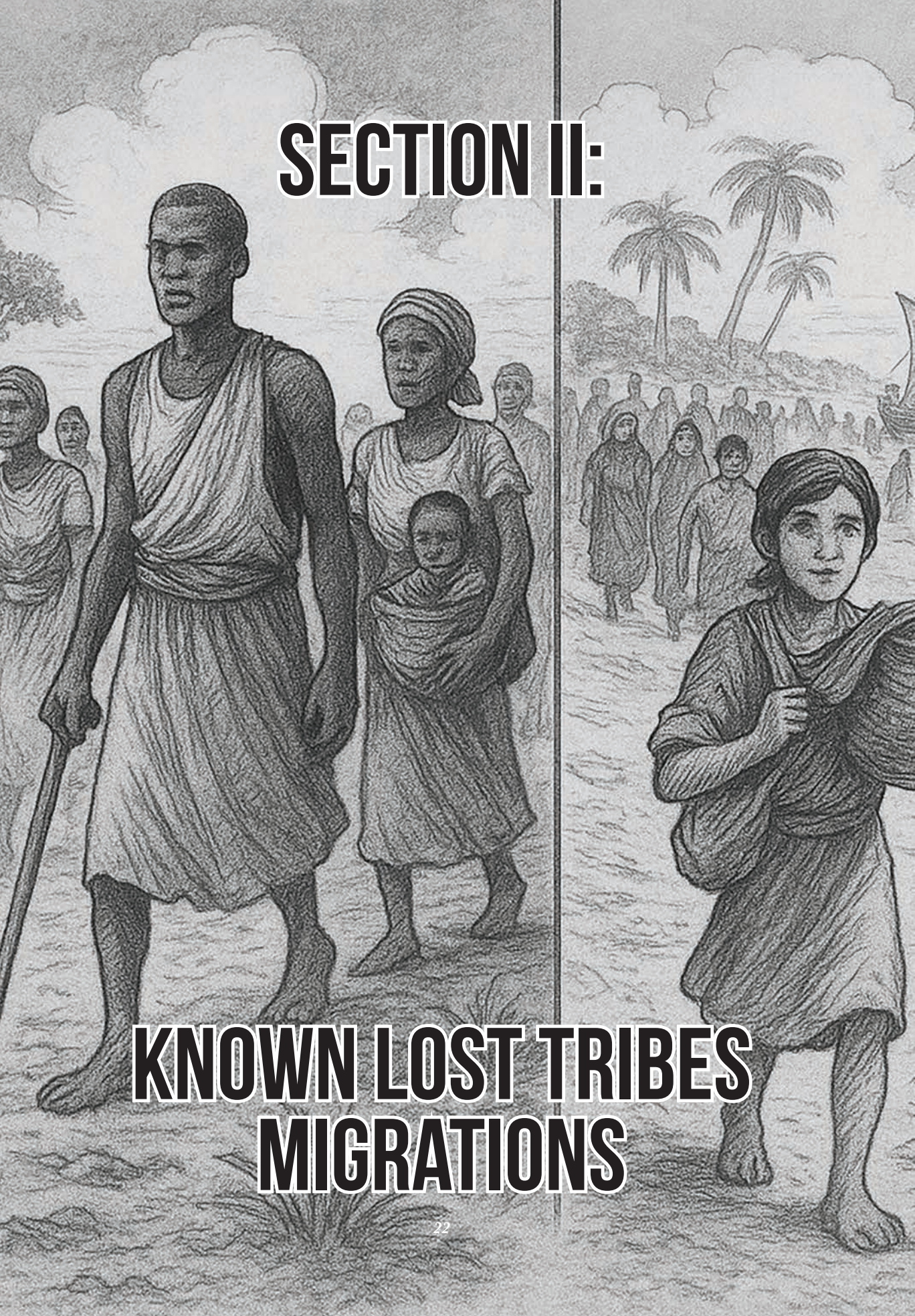



## The Division of Israel

After Solomon, the united kingdom fractured into two distinct nations:

- ✘ The Northern Kingdom – “Israel,” comprised of ten tribes.
- ✘ The Southern Kingdom – “Judah/Judea,” comprised of Judah, Benjamin, and many Levites.

*This division is essential:*

Scripture never records these two houses reuniting prior to the Final Judgment.

Ezekiel 39 places the reunion of the whole twelve tribes after the defeat of Gog of Magog, when Yahuah Himself brings fire upon “the isles” and “the coastlands” (vv. 6–25).

Thus, any modern claim of national “restoration” apart from this event contradicts the explicit prophetic timeline.

## The Northern Rebellion

Scripture describes the Northern Kingdom as falling first into idolatry:

- ✘ They abandoned the covenant.
- ✘ They embraced foreign gods.
- ✘ They drove out Yahuah’s presence through rebellion.

Once idolatry entered, exile became inevitable.

The covenant warned repeatedly that disobedience would lead to removal from the land – and in 2 Kings 17, this happened exactly as foretold.

*“There was none left but the tribe of Judah only.” – 2 Kings 17:18*

Every soul of the Northern Kingdom was taken.

Later rabbinic traditions claiming otherwise are leaven, not Scripture.

## The Assyrian Conquest (ca. 750 BC)

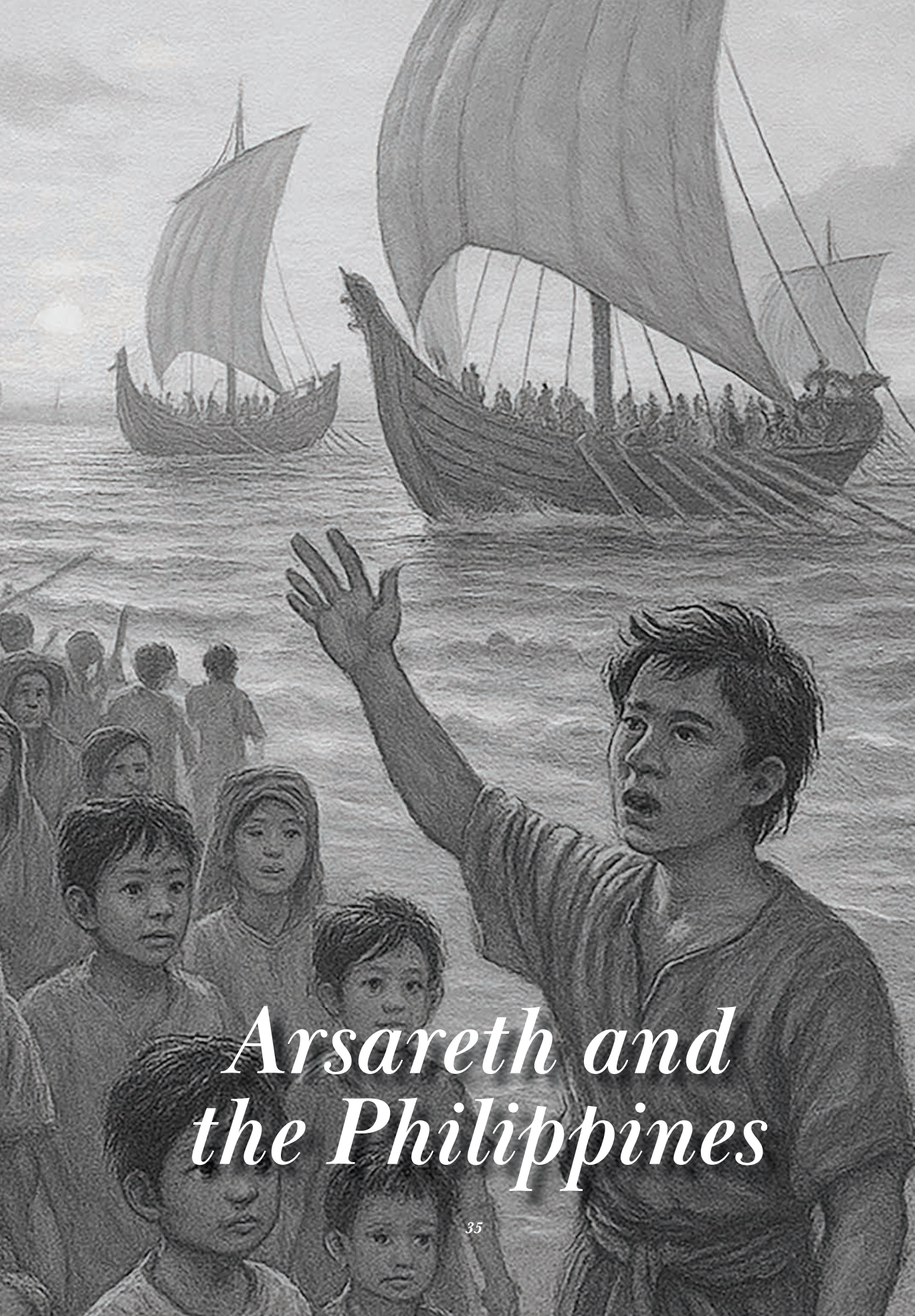

- ✓ The Tigris

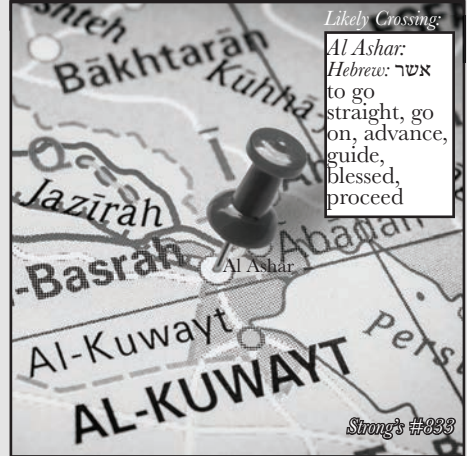
*But 2 Esdras is explicit:*

Though some scattered into every nation on Earth, the Lost Tribes of the Northern Kingdom return from the East in which they migrated originally en masse. This matches Isaiah 11 and 60:9 identifying the location of their return from the isles of Tarshish, the isles of the sea. This is the modern Philippines.

2 Esdras’ “Arsareth” connects to the Hebrew concepts in Genesis 2:4 specifically:

âsâh (עשה) – “to make, to form”  
erets (ארץ) – “land, earth”

All terms historically associated with the Philippines, known for gold, biblical resources, and pre-flood geography matching Genesis.

- ✓ Toscanelli's map (1474) (Zipangu = Luzon, Isle of Gold = Philippines)
- ✓ Behaim's Globe (1492) (Zipangu = Luzon, Isles of Gold & Silver = Philippines)

All placing the Isles of Gold in Luzon and Visayas — not Japan.

### Ferisol, the Italian Jewish scholar



Their descriptions became the backbone of later cartography. Ignorance of that fact is not academic, but often Colonial bias rearing its ugly head.

Among these, Isaiah provides what amounts to a prophetic map of the scattering and future regathering of Israel. His writings, alongside other prophets, identify three primary regions where the tribes would be dispersed—and from which they would return:

- ✓ Assyria / Kurdistan – the first place of exile, some Northern Tribes remained
- ✓ The Philippines – the “islands of the sea,” Ophir/Tarshish/Arsareth
- ✓ Central Africa – “beyond the rivers of Ethiopia” (see next chapter)

These three regions align with:

- ✓ Scripture
- ✓ Linguistics
- ✓ Historical migration
- ✓ Ancient and colonial cartography

We will walk through each in turn, and then expose a false geography that has HIJACKED the narrative.

### 1. Assyria / Kurdistan – The First Exile

As established earlier, the Northern Kingdom was conquered by Assyria and relocated to the eastern side of the Tigris River—modern Kurdistan. This is not vague tradition; it is clearly attested by:

- ✓ 2 Kings 17
- ✓ Assyrian inscriptions
- ✓ Josephus
- ✓ Book of Tobit
- ✓ 2 Esdras

Isaiah II outlines this region with striking precision, using ancient names:

- ✓ Assyria (largely Iraq / parts of Syria and Turkey)
- ✓ Shinar (Mesopotamia / Iraq)
- ✓ Elam (southwest Iran)
- ✓ Hamath (Syria)

Together, these compose the Kurdistan region and surrounding territories. That is not a matter for debate. It is settled fact.

Isaiah 60:9 KJV

Who are these that fly as a cloud, and as the doves to their windows? Surely the isles shall wait for me, and the ships of Tarshish first, to bring thy sons from far, their silver and their gold with them, unto the name of the LORD thy God, and to the Holy One of Israel, because he hath glorified thee.

Isaiah 49:1-3 KJV

Listen, O isles, unto me; and hearken, ye people, from far; The Lord hath called me from the womb; from the bowels of my mother hath he made mention of my name. And he hath made my mouth like a sharp sword; in the shadow of his hand hath he hid me, and made me a polished shaft; in his quiver hath he hid me; And said unto me, **Thou art my servant, O Israel, in whom I will be glorified.**

Messiah predicted the rise of Nineveh and Sheba, Philippines in the Last Days. These are the Northern Kingdom bases. Matt. 12:42



Isaiah 11:11-13 KJV

And it shall come to pass in that day, that the Lord shall set his hand again the second time to recover the remnant of his people, which shall be left, from **Assyria**, and from **Egypt**, and from **Pathros**, and from **Cush**, and from **Elam**, and from **Shinar**, and from **Hamath**, and from the **islands of the sea**. And he shall set up an ensign for the nations, and shall assemble the outcasts of Israel, and gather together the dispersed of Judah from the four corners of the earth. The envy also of Ephraim shall depart, and the adversaries of Judah shall be cut off: Ephraim shall not envy Judah, and Judah shall not vex Ephraim.

2 Esdras confirms this eastern scattering:

“...in the East I have scattered the people of two provinces...” (2 Esdras 1:11)

“I take to witness the grace of the people to come... behold what glory, and see the people that come from the East.” (2 Esdras 1:37–38)

As charted in this book (see chart at end of Chapter 2):

✓ *Jeremiah*, writing around 600 BC, testifies that the Northern Tribes still had not returned.

✓ *Messiah* explicitly sends His disciples to the “lost sheep of the house of Israel” north-east of Galilee (Matt. 10:5–6), without passing through Samaria, clearly differentiating Lost Tribes from Samaritans.

✓ *Josephus*, writing around 90 AD, states that the Ten Tribes remained “beyond the Euphrates”, an “immense multitude.”

This is the first region:

- ✓ The place of initial captivity
- ✓ A permanent homeland for many descendants
- ✓ A continued center of suffering in modern times

Kurdish people today are scattered across at least four nations—Turkey, Iraq, Iran, and Syria within this territory and scattered in at least 66 nations on earth. They have faced repeated persecution, yet maintain a strong identity tied to their homeland. That pattern of being scattered yet still identifiable aligns perfectly with the prophetic picture.

DNA, in this context, is of limited use without accurate migration maps. Those maps have been distorted or ignored. This book restores them.

## 2. The Philippines – Arsareth and the Isles of the Sea

Isaiah repeatedly references the “isles of the sea” as both a place of exile and a staging ground for the return of the tribes. This is not mere poetry; it is geography.

One of the clearest passages is Isaiah 60:9:

“Surely *the isles* shall wait for me, and the *ships of Tarshish* *rst*, to *bring thy sons from far, their silver and their gold* with them...”

Here we have:

- ✓ Isles
- ✓ Ships of Tarshish
- ✓ Sons returning
- ✓ Gold and silver coming with them (their own native resources which matters)

Tarshish in Scripture is:

- ✓ A maritime trading power
- ✓ Linked with gold, silver, ivory, apes, peacocks (1 Kings 10:22; 2 Chron. 9:21)
- ✓ Connected with Solomon's Ophir route and Genesis 2 as Havilah

Those records, when taken seriously (a scholar who does not, is no scholar), yield:

- ✓ A definable sailing range
- ✓ Specific resources (many absent in Spain and the Mediterranean)
- ✓ Ship types matching Far Eastern maritime design
- ✓ A route around Africa and into the Indian Ocean

It was never Spain. Jonah did not sail to Spain; he attempted to flee toward the Far East and was redirected—spat out in a location from which Nineveh could be reached in three days' journey. That only fits a Persian Gulf trajectory—sailing up the Euphrates/Tigris corridor, not a Mediterranean route by any measure.

When we stop treating Tarshish as a mere etymological guess and test the narrative as historical geography, it points consistently to:

- ✓ and those coming from its sea

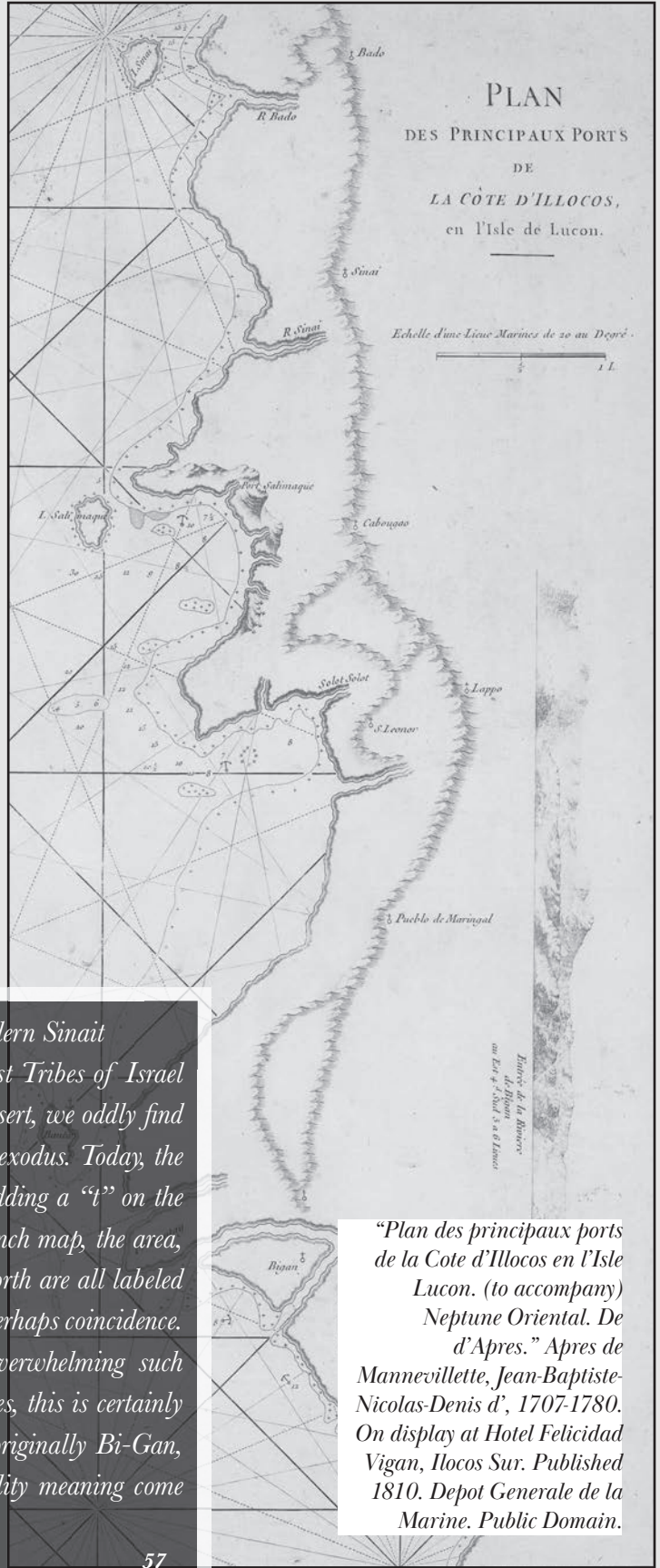

This points not to Sinai (which is inland and not “isles of the sea”), but to islands lying in the sea of Sinim—those off the South China Sea coast.

That is exactly the Philippine archipelago:

- ✓ Sea-bound
- ✓ Adjacent to China, yet distinct
- ✓ Historically known as a greater power than China in most pre-colonial records
- ✓ Never a territory of any other nation until Spain (late 1500s) and later the U.S.

Prophetically, the Philippines emerges as:

- ✓ Arsareth of 2 Esdras (asah eretz of Genesis 2:4 which is Havilah, Philippines)
- ✓ Ophir / Tarshish / Isles of Gold of Solomon’s trade
- ✓ The isles of the sea in Isaiah 11 and 60
- ✓ A major leg in the Eastern Lost Tribes migration

### 3. Ancient Ethiopia / Central Africa – The Southern Migration

While the Northern Tribes largely moved east, the prophets describe a southern migration as well—especially for the Southern Kingdom.

Zephaniah 3:10 declares:

“From beyond the rivers of Ethiopia  
my suppliants, even the daughter of my dispersed,  
shall bring mine offering.”

Ancient Ethiopia (Aithiopia) was not the small modern state alone. Historically it encompassed:

- ✓ Upper Nile regions
- ✓ Nubia (Sudan)
- ✓ Parts of Central Africa
- ✓ The West African coast

Early maps identify:

- ✓ Aethiopia Superior Interior – deep interior Central Africa
- ✓ Aethiopia Inferior Anterior – stretching toward the Slave Coast

Colonial maps and travel accounts record:

- ✓ A region called “Juda” or “Whidah” on the Slave Coast
- ✓ References to “Judaei exiles” in West Abyssinia

- ✓ “Fugitive Jews” or “wandering tribes” in Shankala and Falasjan

These are not modern inventions; they are European cartographic and travel records from the 1600s–1700s.

These same regions:

- ✘ Became primary targets of the trans-Atlantic Slave Trade
- ✘ Were systematically stripped of identity, records, and history
- ✘ Fit the curses of Deuteronomy 28 far more closely than modern Israel does

We will detail this in Chapter 5: The African Migration, but the pattern is already clear:

#### 4. Isaiah's Pattern of Return

Isaiah's "map" is not limited to exile. He repeatedly emphasizes return from the same place they were scattered:

- ✓ From the islands of the sea (Philippines / Ophir / Tarshish)
- ✓ From beyond the rivers of Ethiopia (Central Africa)

This three-region pattern:

- ✓ Aligns with biblical exile history

- ✓ Is reflected in ancient and colonial maps
- ✓ Explains the modern state of these populations: scattered globally, yet anchored to these homelands

#### 5. The Russian Steppes — A False Geography

For several centuries, some theologians and historians have attempted to place the Lost Tribes in the Russian Steppes, stretching across modern Russia, Ukraine, and parts of Eastern Europe. This idea is often fused with the Khazar Empire, whose ruling class adopted Talmudic Judaism in the 8th–9th centuries AD.

But this theory fails on every front:

When these northern regions appear in prophecy (e.g., Gog of Magog, Ezekiel 38–39), they are typically enemies, not the home of exiled tribes.

To place the Lost Tribes in the Steppes is to:

- ✗ Abandon the prophets' geography
- ✗ Adopt later narratives built on post-biblical claims
- ✗ Confuse the migration of the synagogue of Satan (Pharisaic leadership) with that of the tribes of Israel

Even Jewish scholars like Arthur Koestler (*The Thirteenth Tribe*) and Shlomo Sand (*The Invention of the Jewish People*) have raised serious questions about these assumed lineages. No one has ever provided a shred of evidence of this connection.

### Who Were the Khazars?

Historically:

- ✗ The Khazars were a Turkic people around the Caspian Sea
- ✗ Their ruling class adopted Talmudic Judaism centuries after Messiah

Ashkenazi Jews today are widely acknowledged to have strong European and possible Khazar ancestry. Even the name Ashkenaz comes from Genesis 10, where Ashkenaz is a descendant of Japheth, not Shem—and thus, not of Abraham, Isaac, or Jacob.

This is not “anti-Semitism.” It is basic biblical ethnography historically affirmed.

### They Do Not Fit the Covenant Curses

If the Ashkenazi / Eastern European populations were truly the bulk of the Lost Tribes, they would:

These regions fit the prophetic pattern of robbery, displacement, exploitation, and identity erasure far more accurately than Eastern Europe. Let us not forget whose fruits are manifested in that behavior (Satan's: John 10:10).

### No Evidence of a Northern Mass Migration

A massive Israelite migration into the Russian Steppes would have:

- ✗ Left clear biblical signals
- ✗ Appeared in Roman, Greek, and Persian records (there are none)
- ✗ Shaped cartography of the time (nothing exists)



It is no surprise that similar communities persisted outside Roman influence.

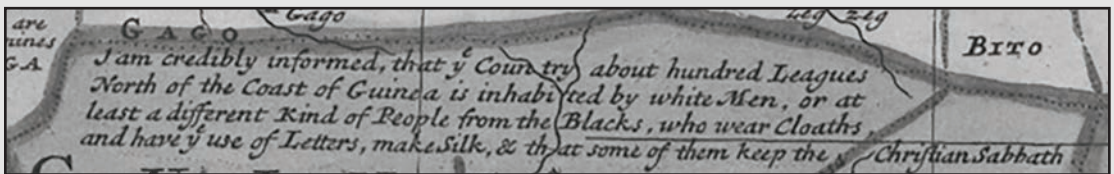
These African tribes were not “pagan converts” but scattered covenant people maintaining remnants of apostolic faith.

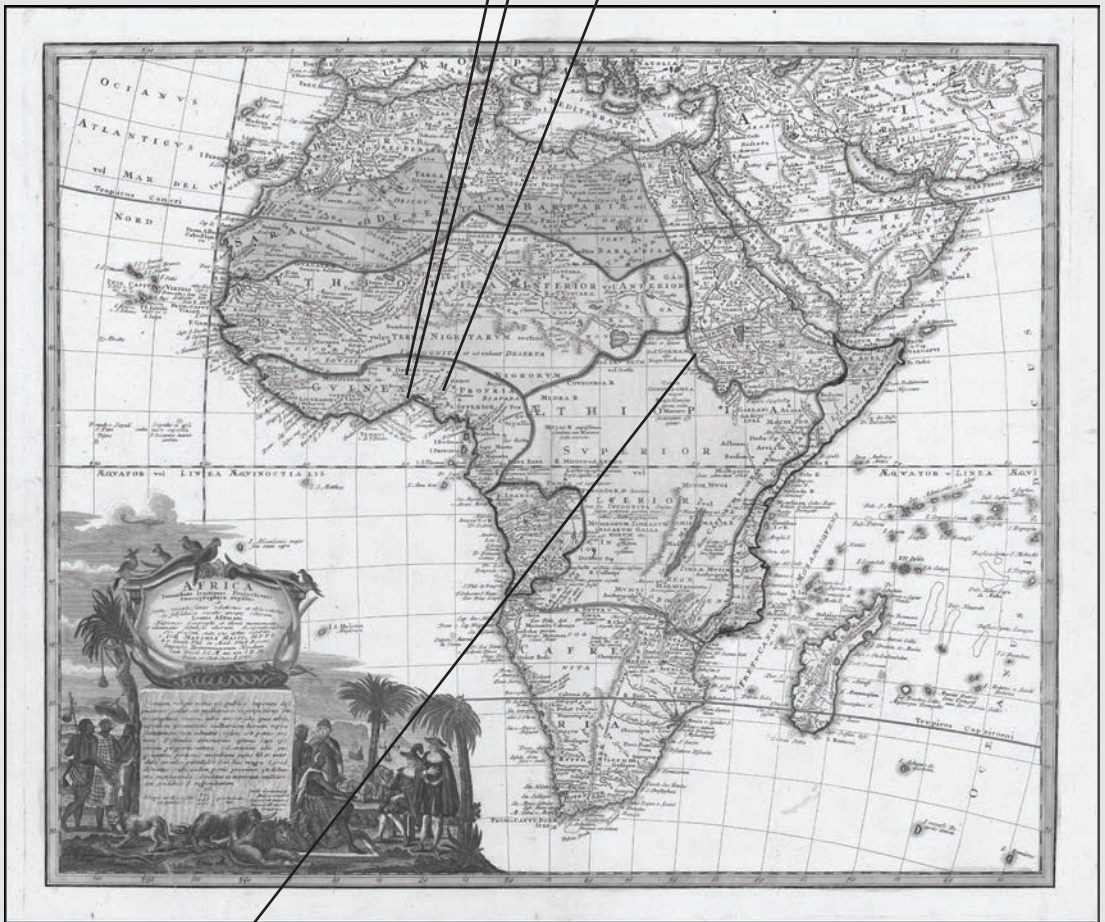

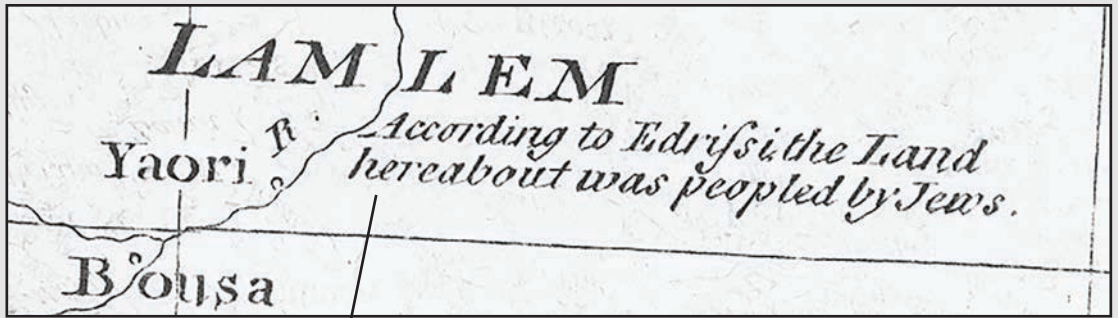

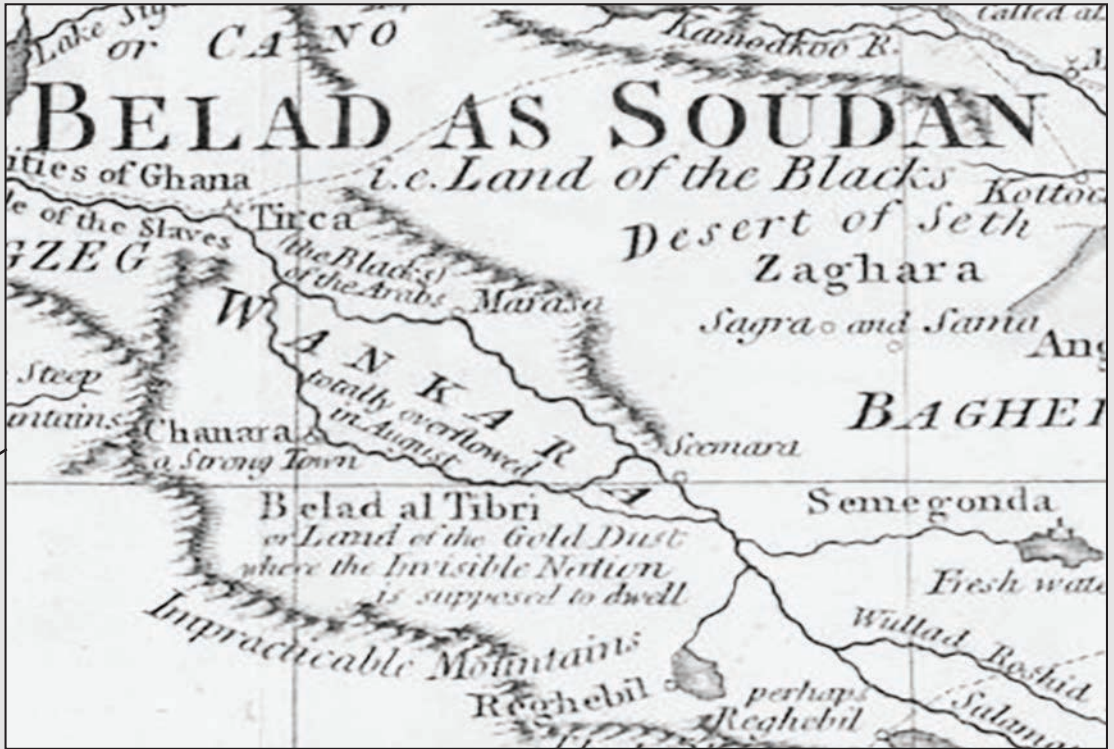

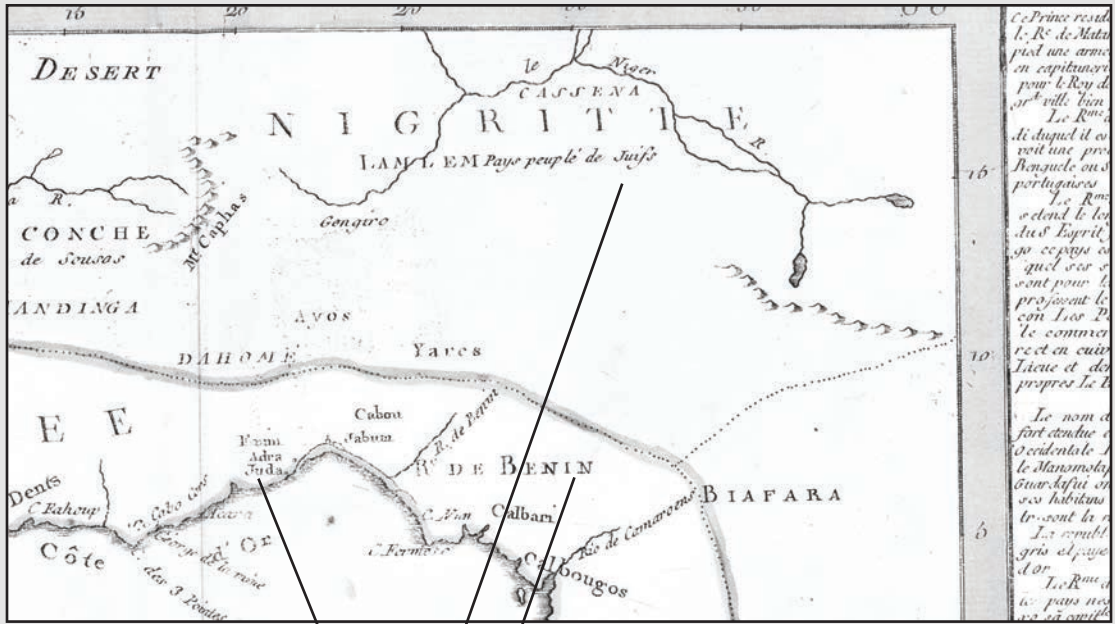

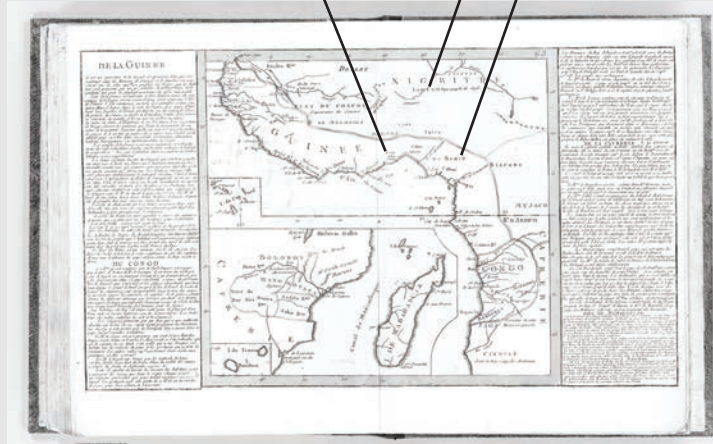

# CHAPTER 6: COLONIALISM AND THE GREAT IDENTITY THEFT



### **A Competing Claim: The Synagogue of Satan?**

The evidence leading up to this point forces us to confront one of Scripture’s most controversial declarations:

“I know the blasphemy of those who say they are Jews (Yahudim) and are not, but are the synagogue of Satan.”

— Revelation 2:9; see also 3:9

Yahusha Himself warned that a group would arise claiming Israelite identity falsely, replacing the true covenant people while working against them.

But replacing ancient Israel with a modern political identity that fails prophetic, geographic, and historical requirements is the ultimate replacement theology—and it is happening today.

### **The Counterfeit Claim in History**

Historically, many of those involved in colonial finance, the Trans-Atlantic Slave Trade, and post-1948 Zionism identified as European Jews. Yet these were not Israelites by descent, but:

✘ Converts

✘ Political claimants

✘ Or descendants of Judean elites (Pharisees / Rabbinic class)

—not the Lost Tribes.

This fuels the argument that a sect within Jewry (not the whole people) has long operated as a counterfeit Israel, obscuring the identity of the true tribes.

Yahuah does not.



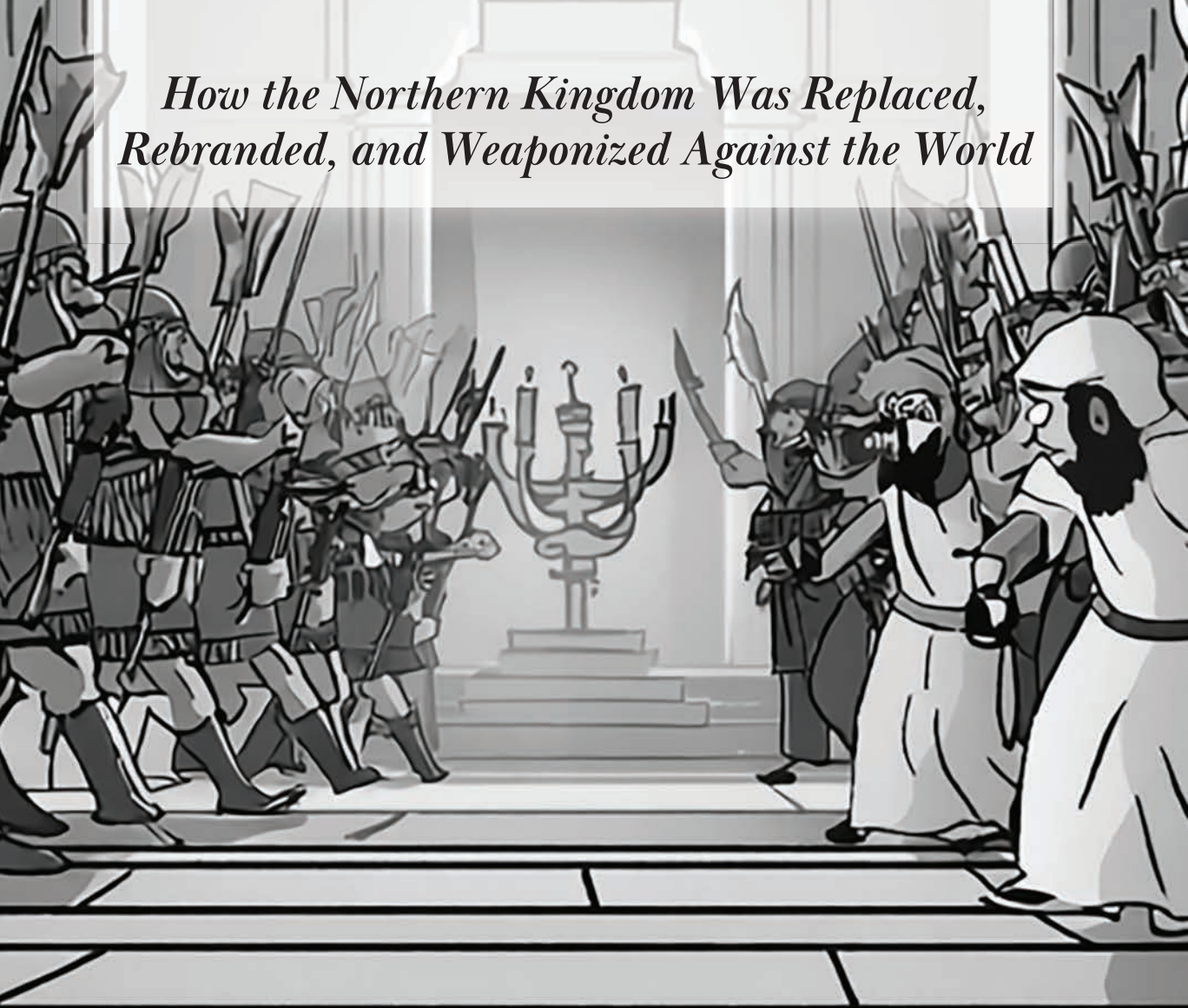

# CHAPTER 7

## THE ENEMY WITHIN

### **Introduction: The Most Ignored Chapter in Biblical History**

There is a chapter in Scripture so explosive, so defining, so essential to understanding the entire history of Israel, Judaism, the Second Temple era, and the modern world, that it should stand at the center of every theological curriculum.

Yet it is routinely ignored, glossed over, softened, or “spiritualized” beyond recognition.

*That chapter is 2 Kings 17.*

Here, the Bible records the complete removal of the Northern Kingdom of Israel into Assyrian captivity, followed by the complete repopulation of their land by foreign pagan nations.

*Completely. “None were left.” (vv. 18, 23)*

The land once held by Israel became a foreign colony filled with:

- ✘ Avites
- ✘ Hamathites
- ✘ Sepharvites
- ✘ And Persians (Farsees)—the linguistic and cultural root of the Pharisee class

*Each brought:*

- ✘ Their own gods
- ✘ Their own rituals
- ✘ Their own priesthoods
- ✘ Their own cultures

This is the origin of the Pharisees, their syncretic system, and eventually Rabbinic Judaism.

This was the first Identity Theft of Israel.

This was the first great HIJACK.

And from this single event flows:

- ✘ The corruption of the Second Temple
- ✘ The rise of the Pharisee system
- ✘ The Babylonian Talmud
- ✘ The “chosen people” narratives used by Europe
- ✘ The foundations of colonial theology
- ✘ The structures of modern Zionism
- ✘ The financial, legal, and political systems that dominate the world today

Let us examine the chapter as Scripture actually presents it—not as religion has rewritten it.

### 1. The Fall of the Northern Kingdom (2 Kings 17:1–6)

The chapter opens with uncompromising clarity:

“The king of Assyria took Samaria, and carried Israel away into Assyria.”

— 2 Kings 17:6

*The text repeats this emphatically:*

“Israel was carried away... unto this day.” (v. 23)

“There was none left but the tribe of Judah only.” (2 Chr. 30:6)

This aligns with Assyrian royal records (Shalmaneser V, Sargon II), which explicitly document the deportation.

*Therefore:*

- ✘ No Israelites remained in the Northern Kingdom after the exile. Not ONE!
- ✘ None returned before the time of Jeremiah, Yahusha, the Apostles, or Josephus.

### 2. Foreign Nations Replace Israel (2 Kings 17:24)

The Assyrian king repopulated the land with foreigners:

*Babylon, Cuthah, Ava, Hamath, and Sepharvaim*

— 2 Kings 17:24

To list them clearly (as it does):

- ✘ Babylon – worshipers of Bel/Marduk
- ✘ Cuthah – necromancers, sorcerers
- ✘ Ava – worshipers of Nibhaz and Tartak
- ✘ Hamath – worshipers of Ashima (ancestor of the term “Hashem”, the god of Judasim today)
- ✘ Sepharvaim – Kabbalists worshiping Adrammelech & Anammelech, tied to worship including the Sephar–highest rung of the Tree of Life
- ✘ Persia (Farsees / Parsi) – the linguistic root of the later Pharisees

*The result:*

- ✘ The land was no longer Israelite
- ✘ The population was entirely foreign
- ✘ Their descendants would later claim to be Israel

This is the beginning of the false claim to Israelite identity.

### **3. Judgment by Lions and the Imported Priest (2 Kings 17:25–28)**

Yahuah immediately judged the new settlers:

“Yahuah sent lions among them.” – v. 25

The Assyrians misunderstood, thinking they were being punished for not honoring the “god of the land.”

To solve the problem, they returned ONE priest (not a return migration) from the former Israelite population:

“...one of the priests whom they had carried away...” – v. 28

This confirms again: All Israelites were carried away.

This lone priest taught the foreigners rituals, not covenant obedience—creating the perfect pathway for syncretism, not Torah restoration.

This never represented a return of the Northern Tribes.

Every prophet after this—including Yahusha—affirmed the Northern Tribes were still in exile. They also rebuke Samaria heavily. Overlooking that is not scholarship.

### **4. A Hybrid Religion Is Born (2 Kings 17:29–34)**

Here lies the theological earthquake:

“They feared Yahuah, and served their own gods.”

– v. 33

This is syncretism—the blending of Israelite ritual with pagan religion.

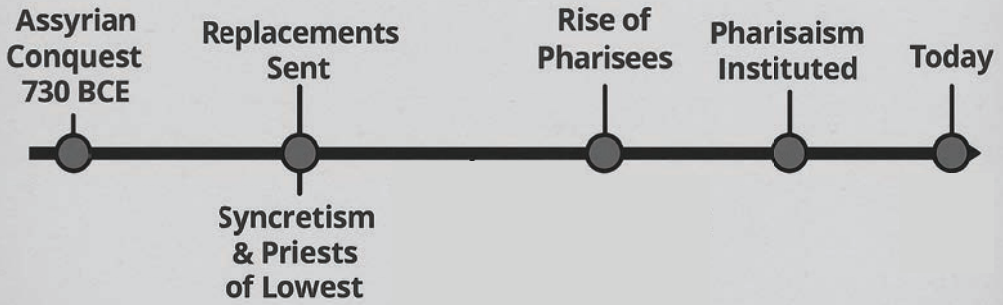



But this version is not what Scripture, archaeology, geography, or the earliest manuscripts reveal.

The historical Hasmoneans were not Hebrew liberators.

They were foreigners, usurpers, and prophetic fulfillments of the very enemies Scripture warned would infiltrate Israel from within. They still are.

- ✘ Southern Samaria, within the ancient territory of Dan
- ✘ A region populated by Assyrian settlers, not Israelites
- ✘ The same region repopulated in 2 Kings 17

*Therefore:*

- ✘ The Hasmoneans were Samaritans by geography
- ✘ Philistine–Hamite line (Gen. 10 LXX) by ancestry
- ✘ Assyrian replacement stock by prophetic identification (2 Kings 17)

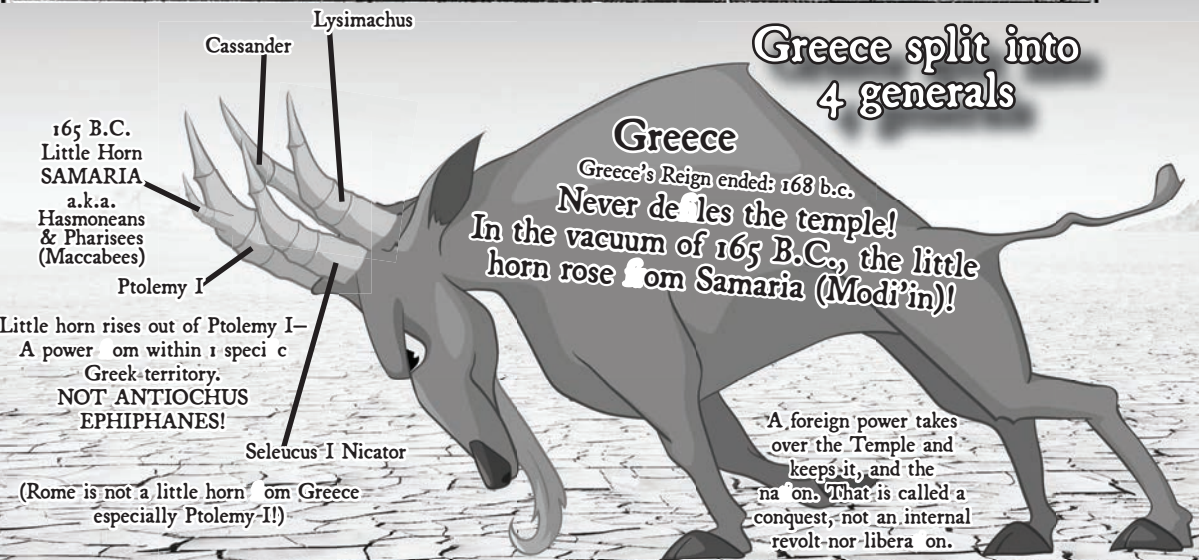
The local history from the 1st century B.C. in Qumran exposes the Wicked Priest (Pharisees and Hasmoneans) de led the Temple and it records Greece never did.

- ✘ Hagarenes (Egyptian Essenes, 5:6–16, who never lived in Qumran)

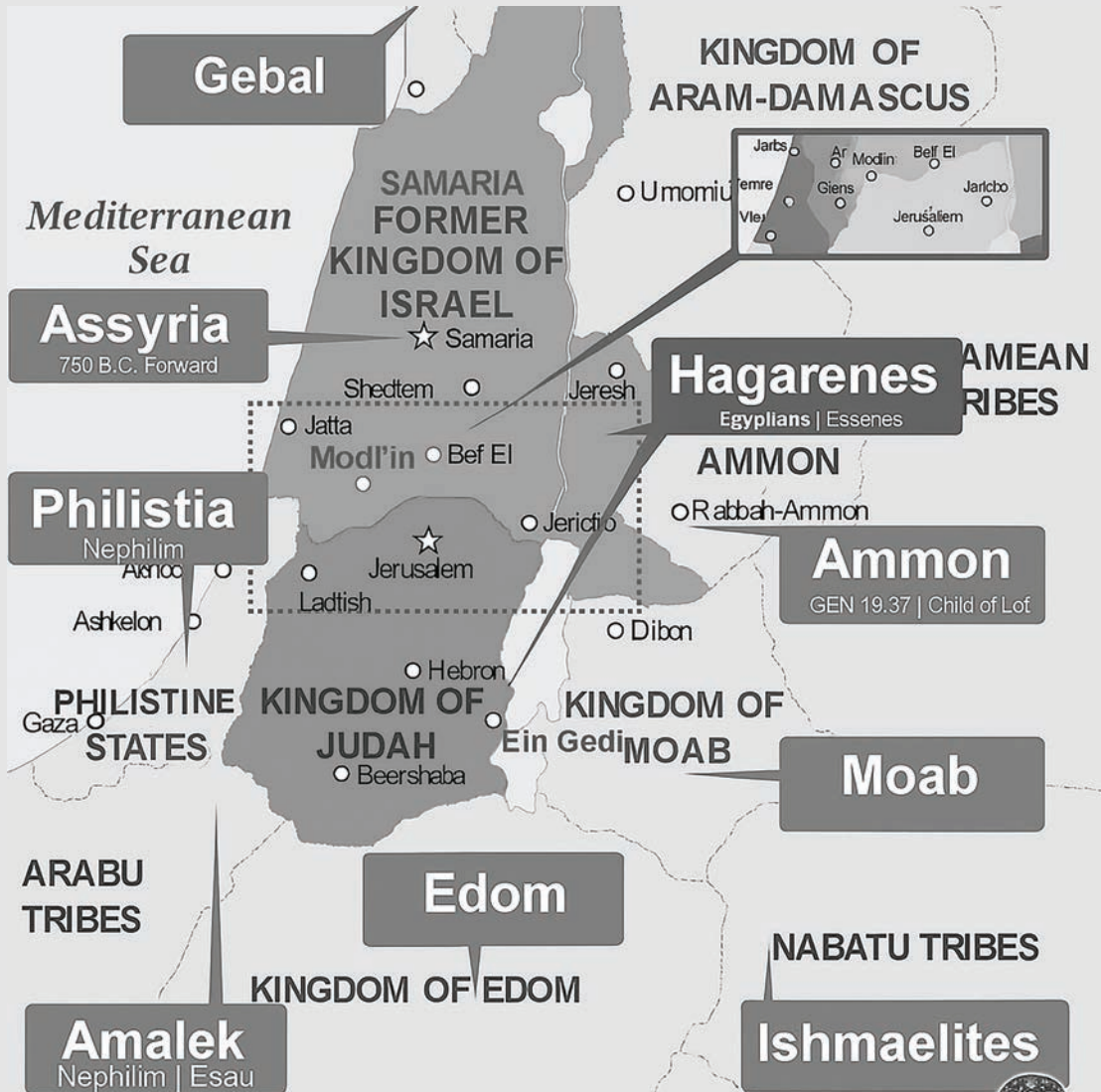
Incredibly, Maccabees documents the exact list Psalm 83 prophesied.

The Hasmoneans were the Psalm 83 coalition, and they admit it.

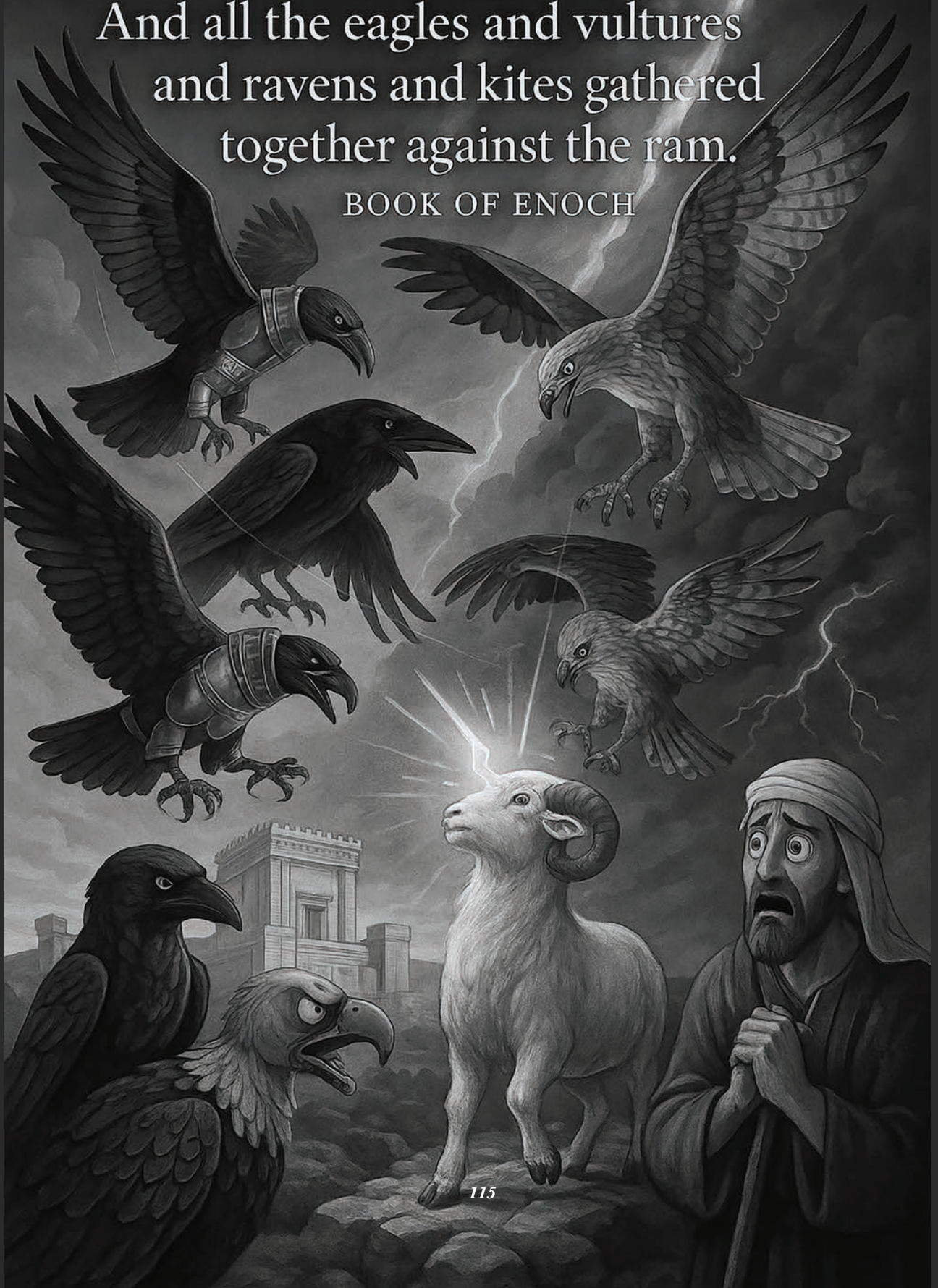
# PSALM 83 FULFILLMENT BY THE MACCABEES

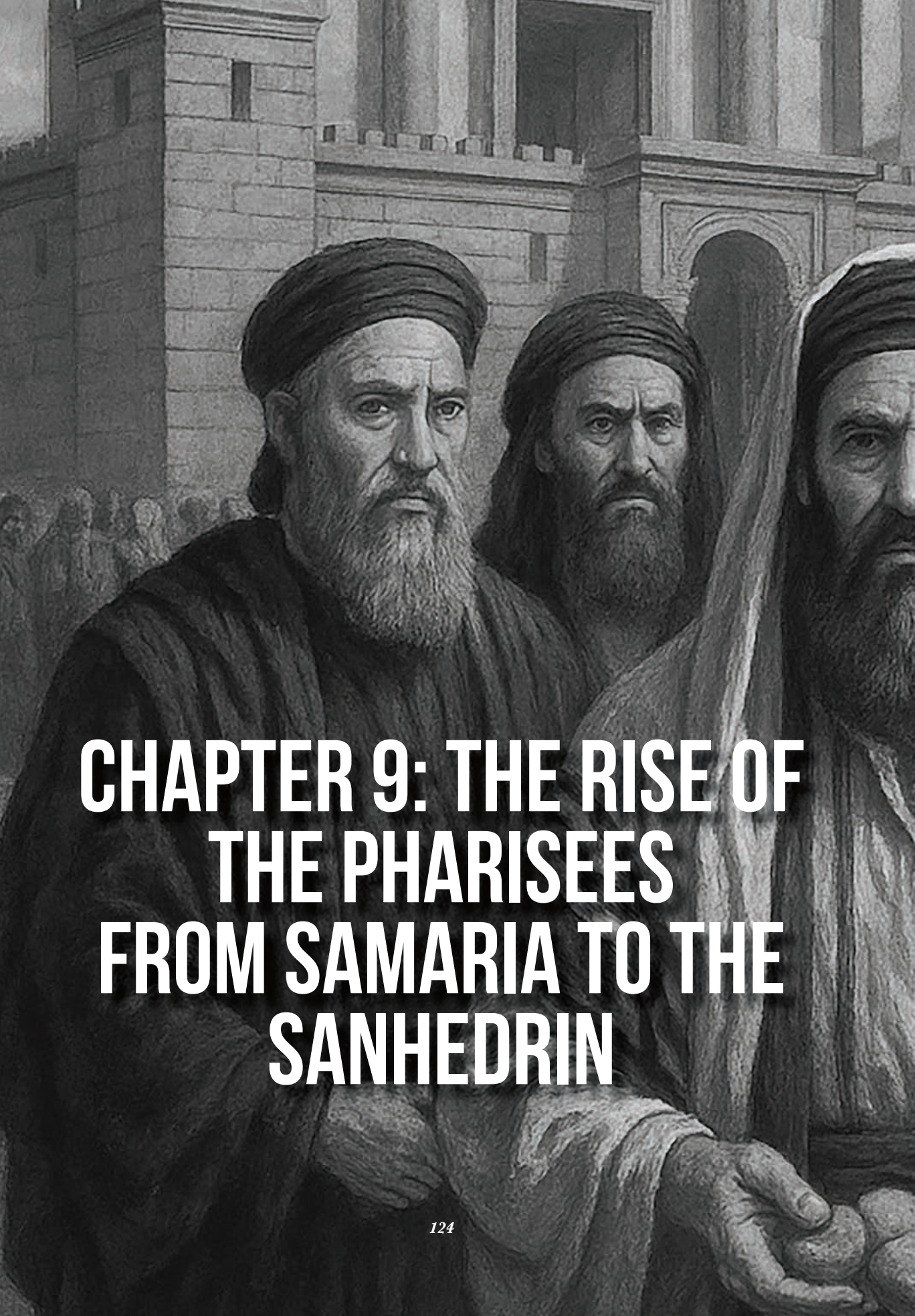



By the time Yahusha (Jesus) walked the earth, the Pharisees appeared to the people as:

- ✘ teachers of the law
- ✘ guardians of tradition
- ✘ religious authorities
- ✘ representatives of Israel

But Scripture, history, geography, the Greek Septuagint, and the Dead Sea Scrolls reveal a far different truth:

- ✘ The Pharisees were not native to Judea.
- ✘ They were not descendants of Zadok.
- ✘ They were not the heirs of Moses.
- ✘ They were not the continuation of the biblical relationship never called Judaism.

They were the religious branch of a foreign population imported by the Assyrians, empowered by the Hasmonean coup, and shaped by Babylonian legalism.

### 1. Their Origin: The People of 2 Kings 17

“You do err, not knowing the scriptures...”

— Matt. 22:29

He was not confronting Torah-keepers.

He was confronting tradition-keepers. New added tradition as he rebuked.

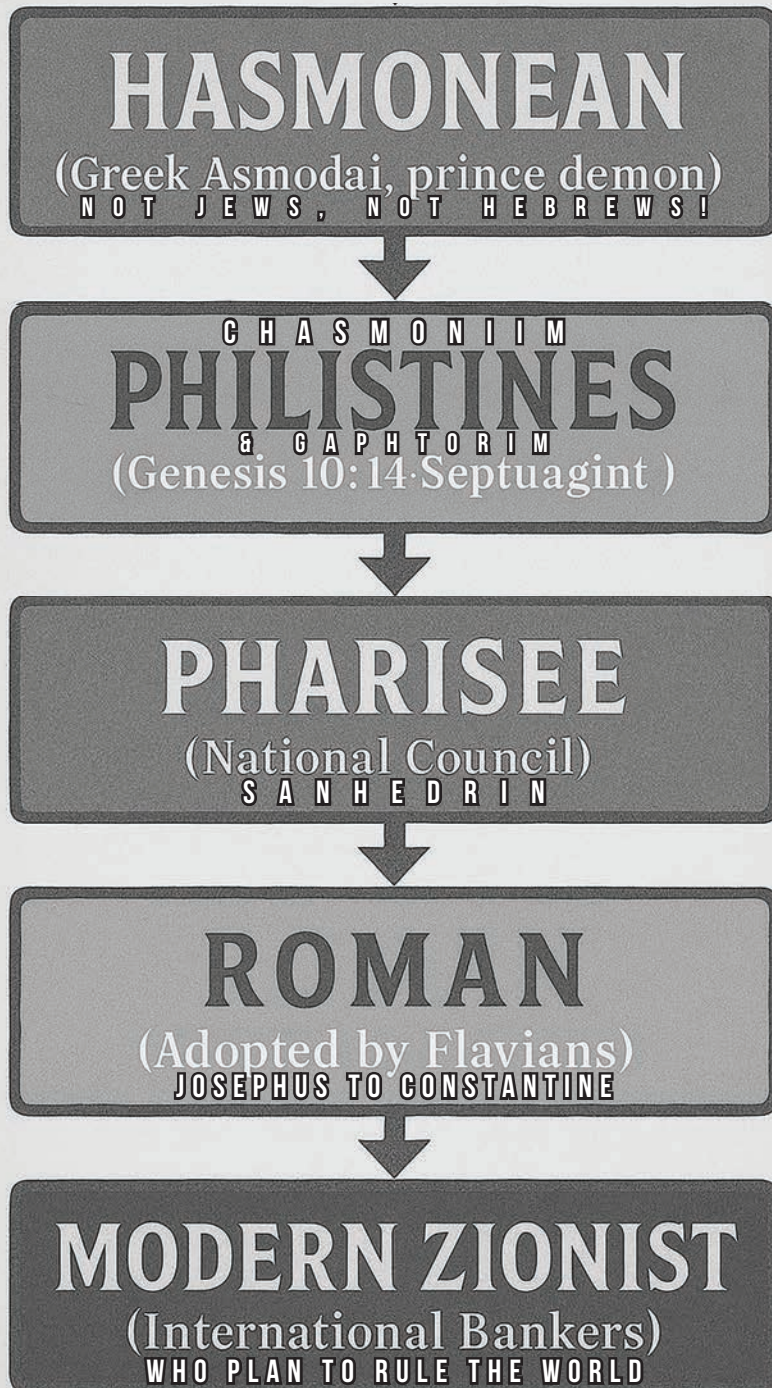

## 1. The House of the Crossing

Bethabara (“House of the Crossing”) identified in John 1:28 as the place where John the Baptist operated and Yahusha was baptized. Scripture was kept there among the Sons of Zadok who were maintaining their calling since Moses commanded. There is no other site on earth which one could literally define as the Ancient Library of the Bible. Every book of the Old Testament, except Esther, was found there in fragments, with some in whole. All texts found there must be tested.

- ⊗ **Geographic correlation:** near the Dead Sea, matching the Qumran site. John tells us it is “beyond Jordan”. Traveling from Galilee southward, this places one in Qumran, never on the East side of the Jordan River. *Jordan = Jordan Valley system.*
- ⊗ Early maps (Madaba Mosaic, 6th century) confirm this location as does Joshua 15:61-62. Maps continue to identify Bethabara in Qumran to the 20th century.
- ⊗ *Why modern scholars relocated Bethabara:* to sever Qumran’s link to the Gospel and hide their altering of Bible Canon. Only the Zadokite Priests carried that ordination from the days of King Solomon. They remained holy according to Ezekiel.

## 2. The True Qumran Community

- ⊗ Scrolls describe the Sons of Zadok, not “Essenes.” Word *Essene* NEVER mentioned!
- ⊗ The Teacher of Righteousness matches the Zadokite high priest lineage, not a separatist cult.

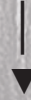

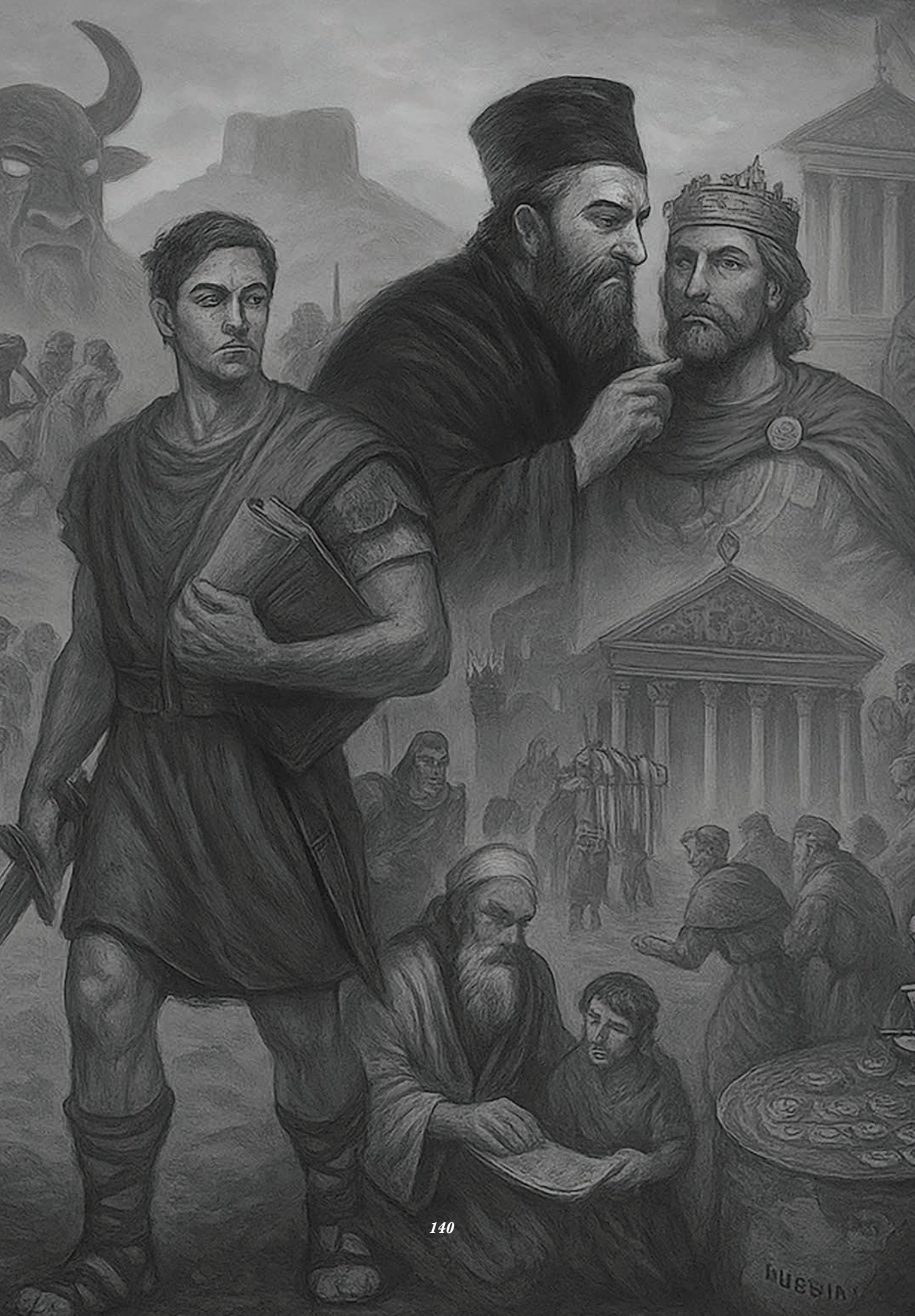

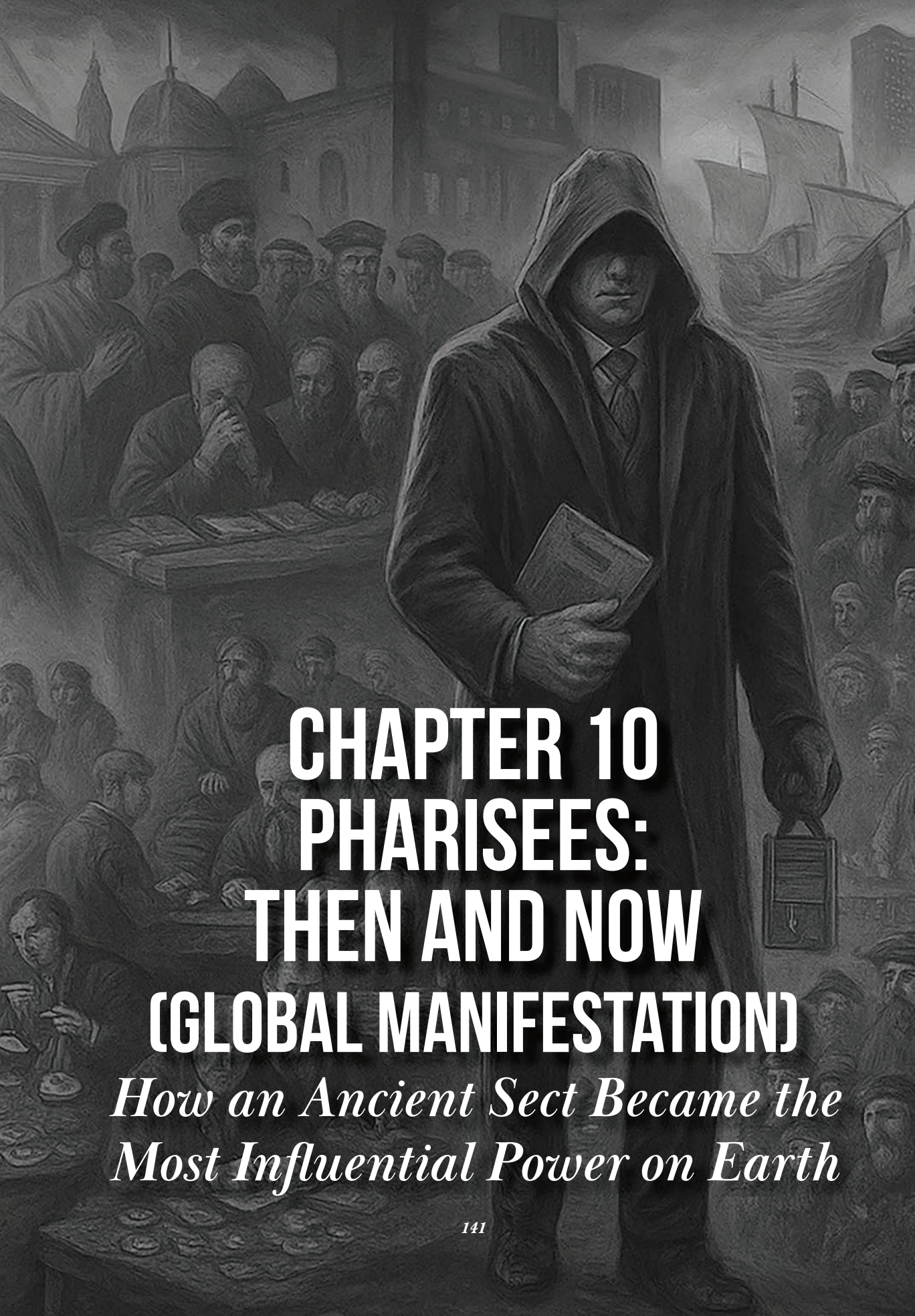

Cultivate *moneylending, banking, and trade networks* in Europe and beyond. Some elite families become major *creditors to monarchs*, funding wars and colonial ventures. Often accused (rightly or wrongly) of *usury, monopoly, and political leverage through debt*.

Claim to uphold Torah, but Yahusha, the prophets, and Qumran texts witness that *Pharisaic tradition negated Scripture*. Their “oral law” is treated as superior to written revelation, effectively replacing the commandments of Yahuah.

*Replaced the sons of Zadok*; took the Temple by force through the Hasmoneans; later controlled the Sanhedrin. Exiled the legitimate priesthood to Qumran. In modern times, their spiritual heirs again occupy the land without covenant right.

Operate through *closed councils, rabbinic courts, and internal rulings* inaccessible to the laity. Decisions shaping nations and communal behavior are made by a small inner circle claiming divine authority.

Jewish communities (especially where *Pharisaic / Rabbinic elites* dominated finance and policy) were *expelled, restricted, or ghettoized* in *dozens of countries*. The same accusations repeat: usury, political intrigue, double loyalty. This does not justify persecution, but it reveals a *recurring pattern of tension* between this elite and host nations.

**Ignatius of Loyola: Catholic Saint or Kabbalist Strategist?**  
Ignatius Loyola is widely honored in Catholic tradition as a devout reformer. Yet some historical lines suggest he was a converso / Marrano of Jewish ancestry, operating with Kabbalistic and mystical frameworks more than simple Biblical faith. His Spiritual Exercises bear structural resemblance to mystic initiation systems, not the plain reading of Scripture.

In other words: the Jesuit Order may itself be a fusion node — just as the Pharisees fused Persian, Babylonian, and Israelite elements, Loyola fused Catholic forms with cryptic mystical substance.

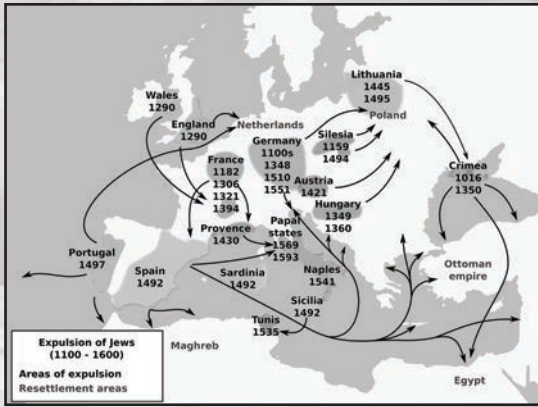

## **INTRODUCTION – THE PROPHECY NO ONE WANTED TO TOUCH**

For centuries, theologians have misdirected world history by treating Gog of Magog as a distant, mythical apocalypse—something for a future generation, something vague, something “over there.”

Some pointed at Russia. (*Wrong seat of power*)

Others at China. (*Wrong seat of power*)

Others at an unnamed “future enemy.” (*Not a mystery to scripture*)

In every case, scholars pushed the prophecy away from the systems that actually matched it.

But Scripture, ancient geography, the Table of Nations, Jubilees, and modern geopolitical history form a single, unavoidable conclusion:

**Gog of Magog is not a future invader.**

**It is a present empire.**

**Invisible to the masses.**

**Visible only to those who read Scripture with both eyes open.**

Gog is not a race.

Not a nation.

Not the Jewish people at large.

Canaan received West Africa but he chose to take land from Arphacsad instead. He stole what would become the land of Canaan thus it's name before it was Israel. **"...Noah their father, and he bound them all by an oath, imprecating a curse on every one that sought to seize the portion which had not fallen (to him) by his lot." (9:14)**

*Ezekiel's prophecy requires:*

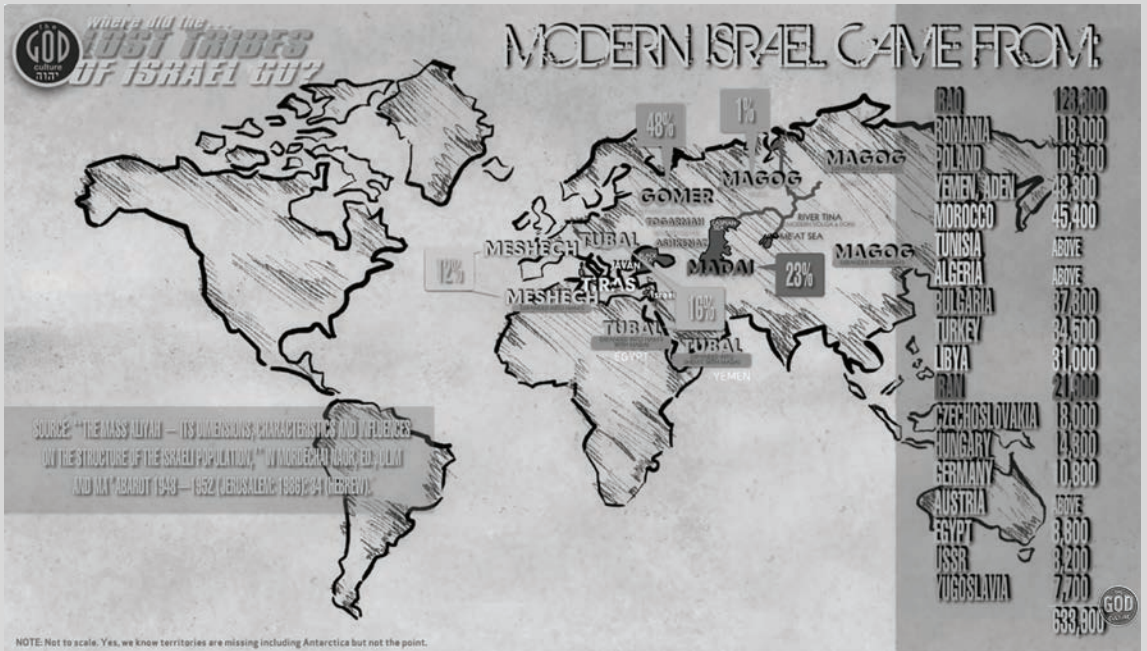
- ✓ Gog = a JAPHTHETIC ruler

Everything aligns. Nothing points to Russia.

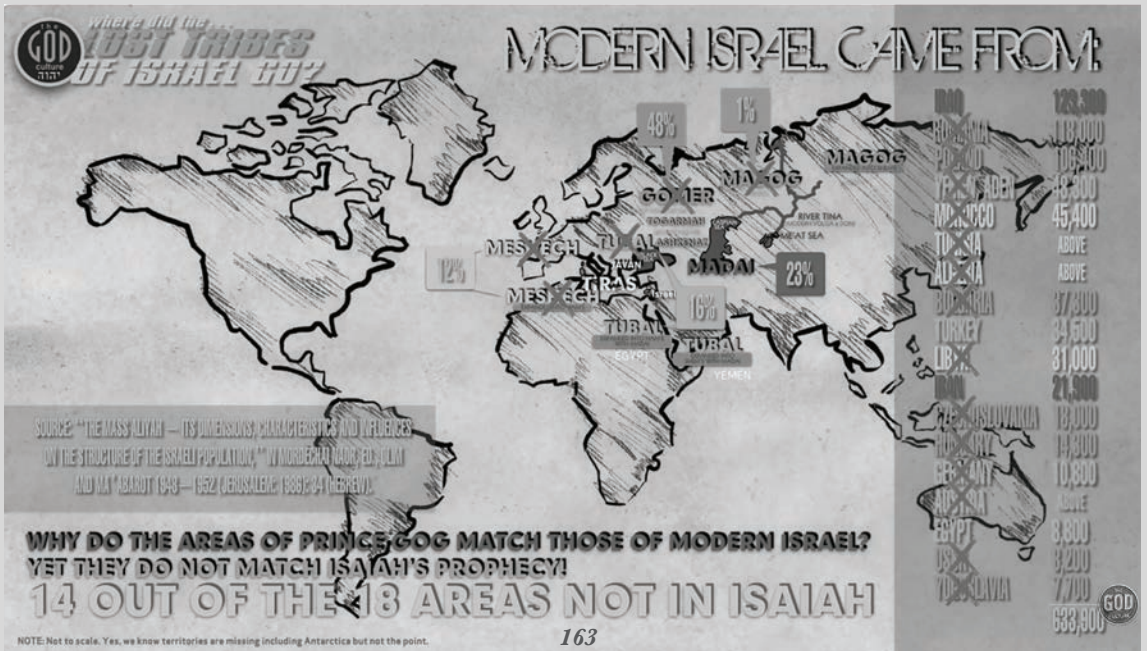

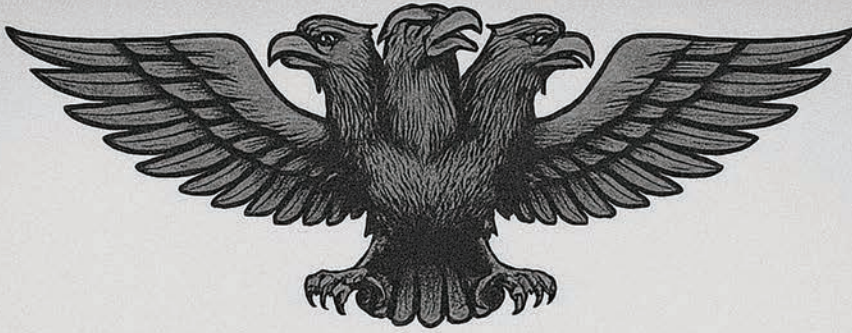

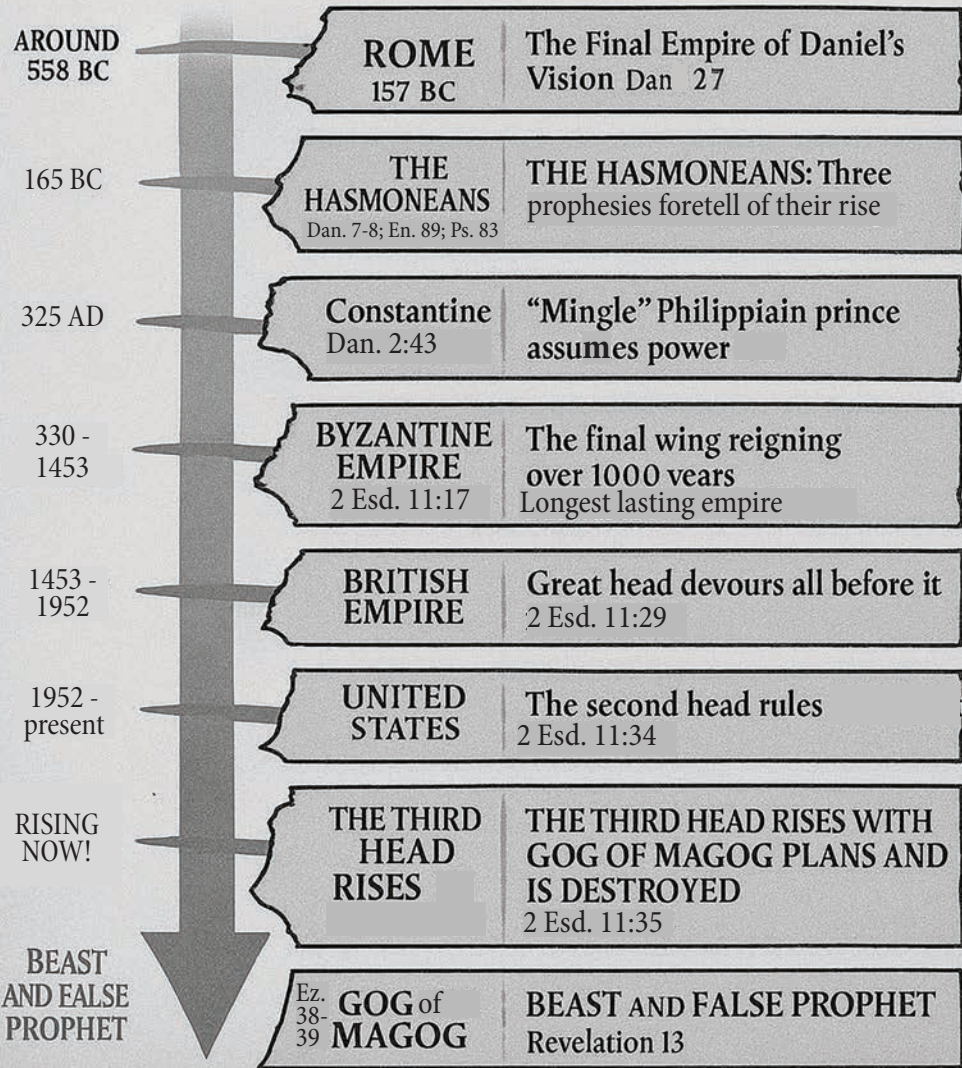

### **SECTION 1 – The Persian Origin**

#### **Mithraism: The First Link**

Long before Constantine, Rome absorbed the Persian god Mithra — the divine Mediator, Judge, and “Firstborn of the High God.” Roman soldiers embraced him as:

“The Unconquered Sun.”

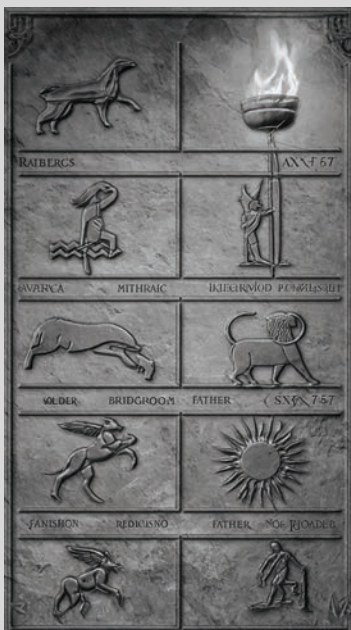
Under Aurelian and Diocletian:

Constantine the Great stands at the fulcrum of world history: the man who fused Roman imperial power with a newly redefined, newly politicized Christianity. But the historical question of his lineage—particularly his mother Helena’s ancestry—has been obscured, minimized, or dismissed for centuries. Strangely, early traditions preserve hints that Helena was not of Roman pagan stock, but of Jewish descent, a possibility with explosive implications. When these traditions are considered alongside the Flavian adoption model we have already established, the pieces lock together with remarkable coherence.

If Helena was indeed Jewish, Constantine becomes not simply the first Christian emperor, but the embodiment of the mingled seed prophesied in Daniel 2:43—a hybrid Roman–Jewish dynastic figure whose rise completes the arc that began with the Hasmoneans and their Roman entanglements.

## I. Helena in Early Christian Literature: A Jewish Memory Preserved

The earliest recorded tradition linking Helena to Judaism appears in the *Actus Silvestri*, a late 5th-century text that dramatizes the conversion of Constantine and the triumph of Christianity over both paganism and Judaism. In this narrative, Helena is portrayed as a woman deeply upset by Constantine’s embrace of Christianity, implying prior adherence to the Jewish faith (*Actus Silvestri* 3–5).

In 1963, historian J. Vogt advanced the thesis that this tradition reflects an earlier, more latent memory of Helena’s Jewish origin. Vogt argued that such a characterization would not have appeared in polemical literature unless it were already recognizable to its intended audience (Vogt, 1963). Anti-Jewish Christian texts rarely assign Jewish identity to positive figures unless such an association was already circulating in communal memory. In other words, the tradition cannot be dismissed as mere fiction: its polemical power relies upon pre-existing belief.

Later scholars, including Jan W. Drijvers, acknowledged the tradition but dismissed it on the basis of genre—labeling the *Actus Silvestri* fictional and therefore unreliable (Drijvers, *Helena Augusta*, 1992). But dismissing content because of literary form is flawed methodology. Legendary material often preserves authentic historical memory, especially when weaponized rhetorically. Drijvers himself admits that these texts proliferated in Rome to demonstrate the supposed “failure” of Judaism compared to Christianity—yet this reinforces, not weakens, Vogt’s point. A polemical argument is only effective if it draws upon an existing cultural association.

Thus the earliest Christian image of Helena as Jewish cannot be brushed aside; it must be acknowledged as a real historical tradition, whether or not modern historians find it comfortable.

## II. Eusebius's Testimony: Far From Disqualifying

Some attempt to counter the Jewish-Helena thesis by appealing to Eusebius, who wrote that Constantine “made her God-fearing, though she had not been such before” (Life of Constantine 3.46). Modern interpreters assume this must mean Helena was pagan, not Jewish. But in early Christian rhetoric, “God-fearing” (theosebēs) was a moral category, not an ethnic one.

A culturally Jewish woman who was:

lax in devotion,  
insufficiently observant, or  
influenced by Hellenistic cosmopolitanism

...could easily be described as “not God-fearing.” Eusebius is not addressing Helena’s ethnicity but her spiritual attentiveness. This phrase does not negate Jewish origin. In fact, Eusebius’s wording is precisely what we would expect if Helena were a Hellenized Jew whose son’s conversion rekindled piety.

Thus Eusebius offers no contradiction to the early Jewish tradition.

## III. Helena’s Name, Region, and Religious Leanings

### 1. Her Name: Helena

The name “Helena” appears frequently among Hellenized Jews of the 1st–3rd centuries. The most famous example, Queen Helena of Adiabene, was a major Jewish convert whose story was well-known throughout the East (Josephus, Antiquities 20.17–96). The association between the name Helena and Jewish piety would have been instantly recognizable in the eastern provinces where Constantine’s mother was born.

### 2. Her Birthplace: Bithynia/Pontus

Bithynia was a region with:

a dense Jewish diaspora,  
documented synagogues,  
trade routes connecting to Judea, and  
communities known from Josephus and Philo.

Helena's birthplace at Drepanum—later renamed Helenopolis by Constantine—is exactly the sort of city where a Jewish merchant or artisan family could have lived and prospered.

### **3. Her Theology: Arian Affinity**

Helena's documented veneration of Lucian of Antioch—the teacher of Arius and of Eusebius of Nicomedia—suggests a theological orientation aligned with Semitic, non-Trinitarian Christianity (Sozomen, Ecclesiastical History 1.2). Arianism's focus on the One God and the First-born echoes Jewish Christian currents far more than Greco-Roman religious philosophy. Helena's affinity for Arian teachers fits naturally with a Jewish intellectual background.

### **IV. The Flavian Question: Constantine as a Flavian Without Flavian Blood**

Our thesis in HIJACKED! maintains that Constantine inherited the Flavian name through a line of adoptive Flavian descent, not biological connection. This is consistent with Roman naming customs and with the known pattern of Flavian adoption.

The only historically identifiable non-imperial Flavian from the 1st century with a documented genealogical legacy is Flavius Josephus, the Jewish priest-historian who was adopted into the Flavian family by Vespasian and Titus (Josephus, Life 76).

Constantius, Constantine's father, bore the Flavian nomen despite no genealogical ties to the imperial Flavians. This anomaly is best explained by an inherited adoption lineage—one that passes through Josephus, not through imperial blood.

Thus:

Constantine = Flavian by adoption, not by birth

Helena = possibly Jewish by descent

Their combined lineage = hybrid Roman–Jewish dynastic line

Such a configuration is perfectly consistent with the interwoven patterns we see in the Hasmonean–Herodian–Roman political marriages of the 1st century.

### **V. The Prophetic Dimension: The “Mingled Seed” of Ezra's Eagle**

In 2 Esdras 12, the angel interprets the Final Empire—the great Eagle of the vision—as a second significant power. Daniel describes that it will “mingle its seed” with another (2 Esdras 12:11–12). Historically, Rome did precisely this during the Hasmonean, Herodian, and Flavian periods, intertwining Jewish and Roman political fortunes.

But Constantine represents the culmination of this process:

a Roman emperor,  
bearing the Flavian nomen through an adoptive Josephus line,  
possibly carrying Jewish ethnic ancestry through Helena as well,  
reshaping Christianity into an imperial religion,  
fulfilling the “mingled seed” prophecy both biologically and politically.

Under Constantine, Rome absorbed and redefined Christian theology in a form that mirrored the Hasmonean-Roman hybridization of the first century—an imperial faith directed not by the Apostles nor by the Sons of Zadok, but by an emperor whose own lineage bore the imprint of Roman power and Jewish ancestry fused into one.

This is the Eagle of Ezra completed, the fusion of two corrupt lines into a unified imperial-religious system. Regardless, this did happen under Constantine who founded New Rome in Turkey, the longest-lasting empire exactly as Ezra predicted. Daniel and Ezra align on this perfectly. Of course, one cannot overlook how this brings the Vatican into the picture under Zionism, made a State religion by the origins of Zionism—a continuation of Hasmonean thought and aims. As there are 2 End Times Beasts, this may well define the False Prophet as the Pope and the political head as the leader chosen by Zionism.

### **Conclusion: The Hidden Lineage That Changed the World**

The Jewish-Helena thesis, far from being a marginal curiosity, forms a critical missing link in understanding how Rome’s religious revolution occurred. When combined with the Flavian adoption model, Constantine emerges as a hybrid ruler whose ancestry perfectly embodies the prophetic “mingled seed” of Ezra’s Eagle and Daniel. Early Christian polemics preserved the Jewish memory of Helena because it mattered—because it explained the strange ideological and theological hybridization that took place under her son’s rule.

For centuries, historians have tried to explain why Constantine’s Christianity looked so unlike the Apostles and so strikingly imperial. The answer may be simpler—and more ancient—than they realized:

the empire was transformed by a ruler whose lineage itself was a fusion of Rome’s Eagle and Israel’s unclean birds. This makes sense.
